## FOCUS PRODUCT SCHEME FOR TECHNICAL TEXTILES

Objective of this scheme is to incentivise export of such products which have high export intensity / employment potential, so as to offset infrastructure inefficiencies and other associated costs involved in marketing of these products. Exports of notified products (as in Appendix 37D of HBPv1) to all countries (including SEZ units) shall be entitled for Duty Credit scrip equivalent to 2 % of FOB value of exports (in free foreign exchange). Technical textile products are covered under Table 4 (Sr. No. 32 to 48) of Appendix 37D from 27.8.2009 onwards. The details of technical textile products covered under the scheme are given below:
